**b.** Wage Adjustments for Fiscal Year 2021/22 – Receive staff report and provide direction to staff on implementation cost of living adjustments and wage adjustments for Fiscal Year 2021/22

Ms. Huff reviewed the current wage adjustment methodology which is based on up to a 2% wage increase (upon satisfactory job performance) plus the average of the Western States and San Francisco CPI. The District maximum liability is limited to a maximum 5% increase for any one year. This methodology has been approved for the 3 fiscal years (2020/21, 2021/22 and 2022/23). The CPI wage increase was 1.7%, based on the average of the Western States and San Francisco CPI for 2020.
