e. City of Dixon NEQ Drainage Evaluation – Receive staff report and provide direction regarding the draft Technical Memo (Action)

Mrs. Huff gave a detailed overview of the Joint Powers Authority provided Technical Memo by West Yost. She identified what the objective of this action item was and what the Board's options were at this point in the beginning stages of this entire project.

Many discussions and points were brought up by the Board.

Director Gill voiced his concern of the use of Culvert #4 stating that if it isn't used
there is a strong chance that Interstate 80 will flood. He has knowledge of this
being that the drainage in question goes through his property. He suggested that
we explore the agreement made between the County and Caltrans back when I80 was put in. He also stated that as it sits today the North side pond is too small
and won't be able to hold the projected runoff.

- Director Bei wants a clearer understanding of what our "cubic feet per second (CFS)" baseline is for DRCD?
- Director Viguie referred to the Technical Memo and its mention of 155 cfs. He
 would like more information as to where that number came from. He is not
 familiar with that number and how it came about.
- Director Bei raised concern that as the plan is today it requires a stretch of land to hold the difference in cubic feet of water, between what comes into Tremont 3 from above and what Dixon RCD's drainage limit into RD 2068 is. The issue is where that stretch lies is flat.

After some back and forth discussion the Board agreed that we need to generate a list of questions for West Yost to expand on. The list is as follows;

- In the 2001 study done and paid for by SCWA the "baseline" flow is 40 cfs and now it is referencing 155 cfs. Why is this so different today?
- Can DRCD get an updated flood map from the 1997 map currently being used?
- What are the City of Dixon's build out plans? Not just the NEQ project today but future plans including North of I-80?
- Are there other options to move re-route this water? Possibly to the creek or towards Ulatis?
- The technical memo indicates a slight improvement on the housing of the extra 30 cfs of water by the land owners, but it should be better. What would it take to improve the potential outcome for the 10 year and 15 year storm event by a minimum of 20%?
- What does the 25 year plan look like?

In addition to generating question for West Yost the DRCD board felt it appropriate to discuss what our representatives should bring to the upcoming JPA meeting on June 24, 2020. The list is as follows;

- Many of the West Yost questions can also be brought up in the JPA meeting.
 DRCD feels that all 4 member agencies would benefit from these questions as well.
- In addition, When does the City plan on touching the North side of I-80?
- What is the rate of development projected to be?
- What is Caltrans plan for the future of Dixon?
- If the impacted infrastructure doesn't change but the cfs does who will be responsible for land owner damages?
- What does the design and accountability for down stream flows look like?
- How will we get land owners involved and included on the front end of this project?

At this time the Board is not ready to take any action other than requesting more information. The Board has would like to gather more information before indicated their position on this project. The motion was made by Director Viguie, seconded by Director Bei to obtain more information before voting on this action item. The Board would like to revisit this at a later date.
