b. Ditch Maintenance – Receive Staff report regarding herbicide applications to the Silvey-Joy Lateral (Casey RD) Vegetated Ditch Project and consider options for replanting.

Mr. Currey gave an overview of the chain of events that led up to the Casey Road ditch issue. According to all the information gathered, it appears that the county accidently sprayed the ditch due to the fact that the "DO NOT SPRAY" sign had been knocked down, so it wasn't seen. Then Phil Washburn's staff came behind and sprayed the same ditch. Phil admitted that his staff should have known not to spray that ditch, so he has offered to help recover the loss.

Mr. Bei suggested that we have the city mow the thatch, he believes we will be pleasantly surprised with the regeneration. Mr. Currey stated that we will disc and lightly seed in December.

Mr. Viguie suggested that we try to put signs up in different locations to be more visible.

Ms. Quino also asked that we keep NRCS in mind for possible programs they may have to help cover weird spots.
