OUR MISSION

Dixon RCD's Mission is to provide leadership and to make available technical, financial, and educational resources to local land users for drainage, water quality, and habitat management through competent, cost-effective services, and partnerships.

Will Dixon Resource Conservation District Survive to 75 Years?

A message from Dixon RCD's Chairman, David Viguie ~

Dixon Resource Conservation District was formed by a team of local landowners in September of 1952 to improve drainage for agricultural lands. That was 71 years ago and there have been significant changes in agricultural practices and an incredible amount of growth and development in the drainage service area in that time. I joined the Dixon RCD Board in August 1999 and in that short 24 years, there has been exponential growth in expectations for

services by the landowners as well as the costs for those services.

The need for regional drainage facilities, not just for agriculture but also for a higher density of development in the rural areas and for the increased flows due to urban and suburban development, has not gone away.

As the District is beginning to prepare for our 75th year of operation in 2027, the board and staff are taking a hard look at the drainage services we provide with a focus on the long-term sustainability of the District. Over the coming year, we will be asking these critical questions:

- Is Dixon RCD the best agency to continue providing drainage services within our District?
- Are the costs of services fairly allocated to the lands receiving drainage benefits?
- Do existing agreements between Dixon RCD and other agencies need to be updated?
- Will the historic/existing level of drainage services be adequate under changing land use conditions?
- What is the will of the members/landowners within our service area today?
- What will be the will of the members/landowners within our service area in the future?

At the District, we track Income and Expenses broken into our core cost centers (See Financial Review below). General District Services (which has included support for the Groundwater Sustainability Agency), Ditch Operations, Water Quality Coalition, and Regional Joint Powers Authority. Drainage Fees that are paid by District landowners regularly underfund the Ditch Operations Expenses. Based on a 2016 Rate Study, the Drainage Maintenance Fee rate was adjusted in 2019, 2020, and 2021, but we are in need of reviewing that charge once again. As a board, we have decided to hold off on that formal review until we have better clarity on some of the critical questions listed above.

Despite significant increases to just about every cost out there, Dixon RCD will be able to maintain drainage fees at \$4.00 per acre again this year. In addition to the ability to manage funds from other District cost centers to help offset ditch maintenance costs, another significant cost savings comes from assistance with maintenance from District landowners & operators, and partner agencies.



Dixon RCD, Providing Drainage & Conservation Services Since 1952

A close look at the map below, illustrates one of the District's primary challenges with continuing to provide drainage services. In general, our systems were not designed to accept flows from west of the Union Pacific Railroad Tracks. The Tremont 1 & 3 Systems have large "upper watersheds" west of the railroad tracks that were not included in the design service areas. In reality, the lands do drain to the Dixon RCD systems that do not have adequate capacity to accept them. Development between Highway 80 and the railroad tracks in the City of Dixon's Northeast Quadrant and Solano County's Agricultural Industrial Service Area have the potential to make the problem much worse. A significant amount of Dixon RCD's staff and board time in recent years has been spent trying to resolve differences and agree on regional drainage solutions for these areas.

The Solano County Water Agency and the Dixon Regional Watershed Joint Powers Authority, whose member agencies include City of Dixon, Dixon RCD, Reclamation District 2068 and Maine Prairie Water District, have active planning efforts focused around these issues.


Regional Watersheds map

Can We Divert Flood Flows for Beneficial Uses?

We are exploring this as we look for creative solutions to flooding and water supply challenges that overlap in some portions of our watersheds. With leadership from Solano County and the Solano County Water Agency, public agencies around the County are looking for any ways we can manage “problem water” into “solution water”. Dixon RCD’s Tremont 3 Watershed is one of the pilot areas for these efforts. It has some key features that make this worth exploring: historical flooding issues, upcoming development, an upper watershed with areas of good soils for potential groundwater re-charge. In response to recent droughts followed by floods, the State of California is providing some regulatory relief and financial and technical assistance to encourage use of “natural infrastructure”, especially below ground. There are new opportunities for creative solutions. If you want to try something on your property or have an idea, let us know! Below are a few places to track these efforts more closely.

Interview with Teri Knight

Our partners at the USDA-NRCS office in Vacaville are lucky to have a top-notch District Conservationist in their midst! Teri Knight began her position managing the Vacaville NRCS office in February 2021, following a long and successful career in resource conservation in Nevada. I interviewed Teri in July and learned about her history of conservation on working lands and what she likes about her new(ish) position:

Q: When did you first start working for NRCS?

A: I was the Director of Science and Stewardship for the Nature Conservancy in Nevada for years, when a "dream-job" opened up in 2002 as a Resource Conservation and Development Coordinator in Las Vegas. Those were really cool organizations, working closely with NRCS and doing great work with landowners. We purchased equipment for farmers to implement innovative practices, helped them with their operations and worked with them to protect sensitive species. When Congressional funding for RC&Ds ended, I was offered a position with NRCS in Phoenix for 2 years, and then the District Conservationist position in Las Vegas for 5 years, until I took the Vacaville position.

Q: What is your favorite part of the job?

A: The customers, for sure. I love to see what they are doing, how food comes to our table. The diversity of agriculture and of ecosystems here is super interesting to work in. The population is also quite diverse; I am looking forward to working with more urban customers as those NRCS programs expand.

Q: What area of agriculture would you like to explore or learn more about?

A: I would love to know what happens next after products leave the farm, get to see what happens with our local food. It would be really cool to tour a nut processing facility, tomato processing plant, etc.

Q: What do you like to do when you are not at work?

A: I love to garden, bird watch, travel, get the dogs outside. (See photo for dog details).

Q: Anything you'd like Solano County producers to know about upcoming NRCS activity?

A: The new Farm Bill is supposed to be renewed beginning in October 2023, and a lot of program components can change, so it will be interesting to see what is included in that bill. The NRCS EQIP program tends to stay consistent, but newer programs involving urban agriculture, organics, aquaculture, etc. may be part of the new bill. Please stay tuned as we learn more on the new Farm Bill!

2022-2023 The District's actual net position of \$19,054 for the fiscal year on June 30, 2023 was higher than budgeted due to the delayed maintenance activities that were pushed to the current fiscal year as well as less than anticipated services and supplies expenses. The District's overall cash position of \$594,882 consists of \$548,687 in allocated reserves.

* General District Services revenue is from property taxes, shared services agreements with partner agencies and grants. Expenses include staff and direct costs to fund the District's non-drainage core services (focused on the priority natural resource concerns). Reduced expenses and additional revenues in General District Services continue to offset the negative net position in Ditch Operations.

CURRENT FISCAL YEAR JULY 1, 2023 THROUGH JUNE 30, 2024

2023-2024 The current year budget projects a negative net position of (\$6,931) which assumes \$12,000 in ditch improvement projects (capital expenses). The District experiences year to year variations in positive or negative net position, but continues to maintain our average net position close to zero.

Grant Funding

In deciding whether and how to participate in a grant proposal, Dixon RCD's priorities are to support our core services of drainage, water quality, water supply (including groundwater), wildlife friendly farming and soil health/sustainability. In some cases the grant funding helps offset costs that allow us to pass on those savings to landowners and/or growers. We also strive to balance any expansions in service and/or staffing using grant funds with the District's long-term ability to support them. Dixon RCD is included as a partner agency in several larger grants over the next 3-5 years. Please call us for details on any of the grants listed below.
