a. Dixon Regional Watershed Presentation from Alex Rabidoux –
 Solano County Water Agency

Mr. Rabidoux went over the presentation he gave at the JPA meeting and explained that the Tech Memo 3 is indeed a bit confusing and that SCWA is working with West Yost to make it easier to understand. He stated that communication has been a challenge and SCWA is seeking ways to make things easier. He asked the Board what Dixon RCD needs in order to get a better understanding of things. The board stated that if it can be demonstrated that the project will not create impacts downstream and it can be explained how there is only a 2cfs difference between the discharge numbers, (how that water will be managed), it would help. Flood extents/profiles could also be reviewed to confirm that there are no impacts downstream.

In addition, Mr. Gustavo Cruz, SCWA mentioned that he went out to view the culverts in question with staff from SCWA to better understand the drainage infrastructure in that region. It was mentioned that a walk through with City, RD 2068, SCWA, and DRCD staff should be set up to view the culverts. Ms. Huff could help lead this project in order to further help the communication of the project.

Ms. Huff gave some updates of activities that have happened since February's Board Meeting including the JPA meeting on February 28th and the City of Dixon Planning Commission Workshop on March 12th. During the February JPA Meeting Alex Rabidoux from Solano County Water Agency gave a presentation and facilitated discussion between the representatives and agencies involved. The technical work from West Yest, based on the City of Dixon's Plan, maintains that the project would only result in minor increased flooding impacts downstream. The meeting concluded with the City and developers planning to continue the technical work regarding the Dixon 257 project that will be reviewed at a later time.

A workshop was held by the City of Dixon Planning Commission for the Dixon 257 Project where a lot of concerns and questions were expressed. Dixon RCD will have 45 days to comment on the DRAFT EIR sometime between April through June which will then result in the Final EIR due to be completed by Fall 2024.

Collectively the RCD understands that the large change in modeled baseline discharge numbers might be believable but they would like to to have additional information to better understand how there are such significant changes. They continue to have important questions on how the water from north of the freeway will be managed to avoid impacts.

c. Wage & Benefit Adjustments for Fiscal Year 2024/25. (ACTION)

Chairman Viguie explained to Director Harvey that Dixon RCD has to review/approve employees' wages and benefits every year, but they adopt a methodology that results in a major review of wages and benefits only every three years. Ms. Huff explained that performance evaluations for all of the staff including herself were done. After the evaluations the committee member recommended increases of between 4-5% for all three staff members. This includes 2% in merit and 3% cost of living increases. Ms. Huff also wanted to mention, Edward Jones was not able to re-characterize the 2023 excess

contributions to the retirement accounts as was planned. Instead, Dixon RCD will have to file an excess contribution form to the IRS and pay a 10% penalty. The board agreed to approve the Personnel Committee Recommendations on employee wage increases.
