 - a. Dixon /Solano RCDs Office Management Account for Fiscal Year (FY) 2023 2024 Budget Review Staff's draft joint budget for Office Management for FY 2023 2024, provide input and consider recommending that the Dixon RCD Board approves this budget at its June 14, 2023, meeting (ACTION)

Ms. Huff presented the DRAFT Budget. She explained that the Office Managers from Dixon and Solano RCDs took the lead in developing the budget this year. The expenses will likely be very similar to the previous year. The cabling in the ceiling will need to be upgraded like we did this year for the cables in the walls. This will be a \$15,000 to \$20,000 cost. The 2023-2024 Budget includes building up the ending fund balance by \$10,000 with the plan to do the same in 2024-2025, when the upgrades would be made. This will allow us to spread the costs over two years.

A motion was made by Director Viguie, seconded by Director Jones to recommend approval of the DRAFT Budget by the Dixon RCD Board.

Ms. Huff presented the DRAFT 2023-2024 Budget, starting with a review of the Projected Year End (PYE) for the current 2022-2023 Fiscal Year with an anticipated ending net position of \$5,960.98 before capital expenses. Similarly, the 2023-2024 Budget anticipates an ending net position of \$5,069.19 before capital expenditures. Several other items of note are described in the staff report.
