b. Dixon RCD Fiscal Year (FY) 2022 - 2023 Budget Fund 024 – Review Staff's draft budget for Dixon RCD for FY 2022 - 2023, provide input and consider recommending that the Dixon RCD Board approves this budget and the staff billable rates at its May 11, 2022, meeting – (ACTION)

Ms. Huff presented the DRAFT Budget. Directors Viguie and Jones posed the following questions and observations.

- Director Viguie asked about increases in project revenue. Ms. Huff explained that the proposed budget assumes the JPA will be actively meeting again and that Joanna will be working more hours for Solano RCD. In addition, Dixon RCD billable rates have been adjusted to include overhead hours for the District Manager and Office Manager.
- Director Viguie asked about the proposed increases in Engineering, Legal and Contracted Services. Ms. Huff explained that she anticipates the need for additional services from West Yost Associates this year for advice on regional drainage and project reviews; additional services from Best Best and Krieger to review newly developed Operations Policies and continued need for assistance from Solano RCD staff with the ditch and IT.
- Director Viguie recommended some clarifications to the 2023 Staff Allocation Worksheet to explain the abbreviations.
- Director Jones and Director Viguie suggested we bring a separate item to the Board to review the Ditch Cost Center and determine if we need to be starting the process for a new rate study. They requested a 15 year analysis of the net position, as well as information on staffing levels for the ditch.
