7. Natural Resources Conservation Service (NRCS) Report -

Ms. Teri Knight states that she is happy to be able to attend in person after being in Fresno for four months. She went on to explain that last year Farm Bill provided 92 million dollars and this year it is 190 million dollars which will be a big increase. With this big jump a new tool is going to be used to help sort and prioritize applications. Right now, Vacaville has 35 applications that are being processed having to do with tractor replacement and orchard removal. The next deadline for applications is February 16th and potentially another one in March or April based on funding availability. Lastly, Ms. Knight mentioned that a list was created to help applicants out with their paperwork and that a list of vendors is being compiled and would like the board's input. These items will be sent to Ms. Huff for her to pass along to the board.

9. New Business-

 a. Fiscal Year 2023/2024 Budget – Review and consider budget adjustments for Dixon RCD Fund 024 (ACTION)

Ms. Huff explained that budget adjustments are necessary due to additional ditch maintenance projects for JPA and for Dixon RCD systems as well as server refurbishment expenses. Those expenses add up to an increase of \$127,794. In addition, there would be a partially offsetting increase in revenue of \$65,583 from grant revenues, county property tax, and JPA reimbursements. Ms. Huff also explained one ditch herbicide spray event from last year was pushed into the 2023-2024 budget. These budget adjustments would lead to a change in net position from -\$6,930.81 to -\$69,141.81. Staff recommended using the unallocated fund balance of \$46,196 plus \$16,015 from Capital Improvement Acquisition Reserve Account to fund the expense

increases. The board did not have any questions or concerns on the budget adjustments after the explanations were made and agreed to move forward with the budget adjustments.

b. Consider Personnel Committee Recommended Updates to Employer Contributions for Employee Retirement (**ACTION**)

Ms. Huff explained that a Personnel Committee was held to go over some corrections that need to be made to the retirement employer contributions. Our current Simple IRA only allows employer contribution up to 3% even though 5% has been contributed since it was approved on July 1, 2023. That being said, starting January 1, 2024 Simple IRA rules will be updated to allow up to 10% employer non-elective contribution in addition to the 3% employer contribution. The excess employer contribution that was given in 2023 needs to be re-characterized and corrected in 2024. Down below are the Personnel Committees recommendations and what the board approved as well.

PERSONNEL COMMITTEE RECOMMENDATIONS:

Correct Dixon RCD employer contributions for retirement from up to 5.0% dollar for dollar match to:

- 1. Up to 3.0% dollar for dollar match.
- 2. Beginning January 1, 2024 adopt an employer non-elective contribution of 2.0% for all eligible employees, in addition to up to 3.0% dollar for dollar match contributions.
- 3. Make one time correction contribution in 2024 to each employee's SIMPLE IRA Accounts to adjust for 2.0 % employee

contributions that could not be matched by employer July 1 2023 – December 31, 2023.

*The 2023-2024 Dixon RCD Schedule of Rates will be updated as a result of these changes.

e. Regional Drainage Update – Receive Staff Update, Provide Direction (ACTION)

A new Draft Tech Memo from West Yost was provided which was supposed to estimate impacts from proposed City of Dixon interim drainage projects. Unfortunately, the tech memo did not address any of Dixon RCD's concerns. Ms. Huff provided comments reiterating our concerns on the Dixon Innovation Center Project, see comment letter for more details.

Director Bei attended a Solano County Ag Meeting with Congressman Thompson. He stated that he and four to five landowners/farmers attended this meeting to talk about the state of the agriculture right now which they explained they are worried about where the City is going with things. Besides these updates since the December meeting no action was necessary for this agenda item right now.

f. Consider Proposed Third Amendment to Dixon Regional Watershed Joint Powers Authority Agreement (ACTION)

Ms. Huff explained that two of the JPA member agencies asked if staff can be a representative since they are having a hard time finding people to serve. JPA's attorney from BBK, Anne Siprelle said yes and developed a third amendment allowing this. In addition, every agency (Dixon RCD, RD2068, City of Dixon, and Maine Prairie has to vote on it before it gets taken to the JPA. The Dixon RCD board did not have any problems with this and voted to execute the third amendment to the JPA.
