Ms. Rash also discussed the Federal hiring freeze and USDA doing high priority hiring only.

Mr. Currey reported about the following:

- Phil Washburn will be spraying this week;
- He noted this was a start-up year for Mike Kett and he will work with Director Bei to identify work to be done;
- The District received over 100% of Ditch Fees and will send one more invoice to those who have not paid;
- He noted he met with five agency partners regarding cover crops;
- Regarding the Groundwater Sustainability Agency (GSA:
  - The Technical Staff meetings will start in July;
  - > The City of Dixon and City of Rio Vista are included:
  - He discussed the paying arrangements;
  - > Russ Lester is the public member;
  - > Staff will be the Solano County Water Agency (SCWA); and
  - > The cost will be \$6,000 to be included in the GSA.
- He noted the Dixon Watershed Real Property Acquisition Joint Powers Authority (A-JPA) will be completed by June 30, 2017, and funds will be distributed in July.

#### a. Solano Subbasin Groundwater Sustainable Agency – Director Bei

Director Bei discussed the JPA formation of the GSA and the members are Farm Bureau, Dixon RCD, Solano RCD, Maine Prairie; Reclamation District 2068, District 4 & District 5. The three agencies doing their own GSA are Solano County, City of Vacaville, and Solano Irrigation District. The Chairman is Supervisor Skip Thomson and Co-Chair is Rio Vista Mayor Norman Richardson.

Director Bei discussed the six initial phase projects and noted that because we are not in a high vulnerable area, the information does not have to be filed with the State until 2022.
